



ACCREDITATION FOR JOURNALISTS AT THE EUROPEAN DOG SHOW EDS 2024, CELJE, SLOVENIA FROM 3 TO 6 OCTOBER 2024

Welcome to the European Dog Show EDS 2024. We look forward to your visit and the attention you give to our event in your media.

We invite you to get accredited via our website <https://eds2024.si/en/press> and thus secure the necessary accreditation for entering and reporting at Celje fair via your e-mail.

Media accreditation is granted by the Kennel Club of Slovenia (hereinafter KZS) exclusively to representatives of the media (hereinafter journalists) who work for media organizations/houses and for journalistic purposes only at the European Dog Show 2024 (hereinafter EDS 2024) for all four (4) days of the exhibition. This accreditation is not issued to professional photographers who will sell any photographs of EDS 2024 for profit.

When issuing accreditations, journalists from newspaper media organizations/houses, websites and journalists from dog sports publications will have the opportunity to obtain journalistic accreditation.

Accreditation for journalists is free.

Applications are reviewed and approved by KZS based on the received evidence specified in this text.

The organizer reserves the right to reject the request for accreditation. The right to accreditation does not exist.

CONDITIONS

All accredited journalists unconditionally agree to the general rules that apply to EDS 2024 and all special additional rules determined by KZS at any time.

KZS reserves the right to revoke the accreditation of all journalists whose behavior disrupts the operation of daily activities of EDS 2024 and other media, as well as public order and peace.



The deadline for applying for accreditation

SUBMIT THE APPLICATION FOR JOURNALIST ACCREDITATION TO pisarna@kinoloska.si NO LATER THAN 15 September 2024.

If we receive the request after the deadline stated in this letter, we cannot guarantee journalistic accreditation in time.

Accreditations - Journalists

Accreditation is granted exclusively for journalistic reporting purposes.

Priority in granting accreditations will be given to press and photo agencies, major national newspapers, large websites and publications in the field of cynology.

Accreditations will not be granted to the following groups of persons:

- persons without journalistic legitimation - official press ID, such as account managers, sales managers, advertising managers or webmasters
- public relations consultants and private escorts
- persons who submit a written assignment from a freelance journalist or photographer
- influencers without journalistic mission
- bloggers and influencers responsible for canine fan pages
- persons who are exclusively privately active on social networks

Please provide the following documents:

- a valid identity card or passport
- a valid (national) journalist card and a letter with a stamp and signature of the responsible editor of the media organization/house you work for, in which a confirmation of your status as a journalist is clear and which event you are covering (in this case EDS 2024)

Journalists who apply for media accreditation from KZS must meet the following criteria:

- they must be employed in a media organization/house or be independent journalists who regularly report on canine matters for a media organization/house
- journalism must be their main source of income

Additional requirements for online media:

- the website must be a professional media website that follows the rules set for media organizations

Most website content should:

- cover canine topics
- cover original news, commentaries or analysis

Criteria for processing the application

All requests for accreditation are reviewed by the KZS. For this purpose, the journalist applying for accreditation may be required to submit additional information/documentation later if needed (e.g. proof of work, etc.).

Approval of the application for journalistic accreditation

After completing the application posted online and sending it to pisarna@kinoloska.si, you will receive an email confirming that your application has been received. We will then process the request, which may take up to 14 days.

When your application is approved, you will receive an email from KZS.

If your application is rejected or if you need to provide additional information, KZS will contact you.

Collection of journalistic accreditations

You will receive an email once your application has been approved.

You can collect your accreditation on the day of your visit to EDS 2024 at the entrance of Celje fair. With the confirmation mail received on your e-mail, you will approach the security personnel at the entrance of the EDS 2024, who, after checking the received confirmation and personal document, will hand you the accreditation.

If the journalist does not want to show the required information to the authorized security personnel when accepting the accreditation, the journalist will not receive the accreditation.

If the journalist does not follow the instructions for wearing the accreditation where it can be clearly seen, the journalist may be removed from EDS 2024 by authorized security personnel at any time of the EDS 2024.

Press center

The press center will be at the reception at the Celje fairgrounds, at Dečkova 1, 3000 Celje, at the EDS 2024. In the press center, journalists will receive all current information.

Accreditation for journalists applies to the movement area, which is limited to the areas specifically intended for accredited journalists at the EDS 2024, from 3 to 6 October 2024.

These are:

1. PRESS ROOM and
2. PRESS TRIBUNE.

Journalists are not allowed to enter the ring at any time.
